Approval of Minutes: The minutes from the November 2007 meeting were unanimously approved.

Athletic Director's Report –Bob Maxey

- A Fall Sports Award Ceremony will be held on December 20 (during the day).
- The company that the school uses to purchase uniforms will provide a price list for letter jackets.
- The gym in the new school is in the final stages. Should be ready by the first home game in January.
- The AD will be attending the National Athletic Directors Conference.
- The AD will coordinate the indoor concession stand, using predominantly student volunteers.
- The Concession Food Service Application will be submitted.
- The monies donated in memorium for baseball dugouts continues to be researched through the business office.
- Discussions with MCPS administration regarding artificial turf for the stadium continue.

Treasurer's Report:

- The financials were reviewed.

President's Report:

- The Winter Team Potluck dinner was a great success. Much larger turnout than expected.

Old Business:

- The date for the Mulch Sale is March 8.
- Discussion was held regarding the need for a separate handbook when the same information is in the handbook from the Athletic Department. It was recommended that several single page handouts be provided (ie. team parent responsibilities) for added emphasis.
- Black and Gold Night for the basketball games will be held on January 18, January 29 and February 1. One of these will also be cluster night.
- The collaboration with the Foundation regarding corporate fundraising is being reviewed. Details such as coordination and distribution of funds are being discussed.
- The membership chair is charged with establishing a focus group and making recommendations to the Booster Club in an effort to increase membership.

- The 1st Annual Mike Curtis Golf Tournament will be held on May 5 and the Booster Casino Night will be held on April 11th. A coordinator is still needed for Casino Night.

New Business:

- Discussion was held regarding the current RMHS website, particularly in regards to the athletic page and lack of updated information. It was suggested that a committee form to work on and make recommendations for athletics and the individual sports pages.
- Armand's Pizza would like to sponsor a fundraiser. A night will be selected.
- Discussion was held, a motion was made, seconded and unanimously approved to expend \$40 to have the logo redesigned. This logo will possibly be used on future Booster merchandise.
- Diane Goleb (former RM parent) is interested in contacting Coca Cola to pursue sponsorship ideas (i.e. scoreboards, seating, etc). Discussion was held and it was agreed to pursue this opportunity. Mike Gorsky (current RM parent) works for Coca Cola and should be a valuable resource in this effort.
- A banner should be purchased to advertise Casino Night and Golf Tournament to be displayed at as many events as possible.
- Discussion was held to do something to recognize the opening of the new gym. The Booster Club would like to see commemorative tickets to celebrate the event.
